NOTICE OF CONSTITUTIONAL AMENDMENT AND SPECIAL ELECTION
AVISO DE ENMIENDA CONSTITUCIONAL Y ELECCION ESPECIAL

To the registered voters of the County of Fort Bend, Texas:
A los votantes registrados del Condado de Fort Bend, Texas:

Notice is hereby given that an election shall be held in the County on the 2nd day of November, 2021, in which all resident, qualified electors of the County shall be entitled to vote for in a special election to adopt or reject the proposed Constitutional Amendments as submitted by the 87th Legislature of the State of Texas and for voters living within the territory of the proposed County Assistance District No. 23 (CAD 23) to vote to approve, or disapprove, the creation of the proposed County Assistance District 23 and the imposition of a sales and use tax at the rate of two percent for the purpose of financing the operations of the district. The polls shall be open for voting at such election from 7:00 a.m. to 7:00 p.m. Fort Bend County has adopted a countywide polling place program allowing voting at each election day polling location, and the election shall be conducted at each polling place, respectively, by the officers previously appointed by order of the Commissioners Court. The listing of polling places for November 2, 2021 is made a part hereof for all purposes.
