In accordance with the above referenced contract, in particular General Requirement - Section 1.35, James Construction Group, LLC (JCG) is requesting a price increase on the items listed below. Liquid asphalt is one of the primary components in Hot Mix Asphaltic Concrete and has increased significantly over the past nine months. In addition, the cost of liquid asphalt delivery has also increased. Attached to this letter is the increased material pricing provided by the liquid asphalt supplier, Martin Asphalt Company, along with increased delivery pricing provided by the trucking company, Trout Trucking. Also attached is the increase per line item based on the increase in the liquid asphalt and delivery, which is reflected in each of the bid items on the table below. JCG proposes the revised unit bid prices for the above referenced contract as follows:
