AMENDMENT TO AGREEMENT FOR CONSTRUCTION MATERIALS TESTING SERVICES

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, HVJ Associates, Inc. (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Construction Materials Testing Services on October 13, 2020, (hereinafter "Agreement"); and

WHEREAS, the parties desire to amend the Agreement to allow Contractor to provide additional Services under the Agreement.

NOW, THEREFORE, the parties do mutually agree as follows:

- County shall pay Contractor an additional amount not to exceed twenty-three thousand one hundred eighty-seven dollars and 50/100 (\$23,187.50) to perform the additional Services, as described in Contractor's proposal dated August 17, 2021 attached hereto as Exhibit "A" and incorporated herein for all purposes.
- 2. The Maximum Compensation payable to Contractor for all Services rendered is hereby increased to an amount not to exceed one hundred fifteen thousand one hundred eighty-seven dollars and 50/100 (\$115,187.50), authorized as follows:

\$92,000.00 under the Agreement; and \$23,187.50 under this Amendment.

- 3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without an agreement executed by the parties.
- 4. BY ACCEPTANCE OF AGREEMENT, CONTRACTOR ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

As requested, this is our cost estimate for an addendum to our contract for material testing and inspection services for the referenced project.

Scope of Services

Our scope of services for the referenced addendum proposal will include the following items.

- Monitoring backfill of utilities, and testing backfilled materials
- Inspecting and testing roadway subgrade, and stabilized subgrade
- Concrete testing for pavement and sidewalks
- Associated laboratory testing

Cost Estimate

The estimated cost to perform the material testing services for the remaining work on this project is estimated to \$23,187.5 as shown on the attached breakdown. A minimum charge of four (4) hours applies to time worked less than four hours in any service call, except for sample pickups, which are charged at actual time. Invoicing for our services is presented on a monthly basis. Payment for monthly invoicing will be in 30 days net.
