

**FOURTH EXTENSION  
TO  
FIFTH STREET WATER AND SEWER SERVICE AGREEMENT**

This Fourth Extension to Fifth Street Water and Sewer Service Agreement (the "Fourth Extension") is executed as of this 15 day of Dec, 2021 by and between Fort Bend County Water Control and Improvement District No. 2, a body politic and corporate and a political subdivision of the State of Texas organized pursuant to Article 16, Section 59, of the Texas Constitution (the "District"), and Fort Bend County, a body corporate and politic (the "County") (collectively, the "Parties").

**RECITALS**

The Parties entered into the Fifth Street Water and Sewer Service Agreement (the "Agreement") dated December 23, 1996, which stated that the Agreement automatically terminated 5 years from the date of its execution.

The Parties subsequently entered the First Extension to Fifth Street Water and Sewer Service Agreement (the "First Extension"), dated January 16, 2001, which stated that the Agreement was extended for an additional 5 years, until January 1, 2007; the Second Extension to Fifth Street Water and Sewer Service Agreement (the "Second Extension"), dated February 27, 2007, which stated that the Agreement was extended for an addition 5 years, until January 1, 2012; and the Third Extension to Fifth Street Water and Sewer Service Agreement (the "Third Extension"), dated January 10, 2012, which stated that the Agreement was extended for an additional 10 years, until January 1, 2022.

The Parties now desire to extend the Agreement for a 10 year term, until 2032.

**AGREEMENT**

For and in consideration of the mutual promises, obligations and benefits of extending the Agreement, the Parties contract and agree as follows:

The Agreement shall be extended until January 1, 2032, and all other terms and conditions of the Agreement remain in full force and effect.

IN WITNESS WHEREOF, the Parties have executed this Fourth Extension in multiple counterparts, each of equal dignity and effect, as of the date and year first above written.
