4. Public Comments regarding the Agenda and Announcements.

Judge George announced today is the last Commissioners Court meeting for 2021. The County offices will be closed on Thursday, December 23 and Friday, December 24 in observance of the Christmas holiday and on Friday, December 31, in observance of New Year's Day.

Dr. Jacquelyn Minter, Director of Health & Human Services gave an update on COVID in Fort Bend County. Dr. Minter stated the new daily reported cases have risen significantly in the past week. When compared to the average daily cases from last month, the cases in Fort Bend County have increased by 50 new cases per day on average. Hospitalizations are anticipated to increase. The County continues the drive through testing by appointment in each precinct and vaccinations are available for eligible residents. Approximately eleven days ago, Fort Bend County confirmed its first three cases of Omicron and will likely be confirmed today to be dominant over the Delta variant in the County. Vaccination continues to protect against severe disease and hospitalization in the majority of people. Dr. Minter encourages everyone to get their vaccinations and a booster and use the techniques we know to come through this current challenge as safely as possible.

Commissioner Meyers wished everyone a Merry Christmas and a prosperous and healthy New Year.
