


Duly put and unanimously carried (5-0), it is ordered, by record vote, the property tax rate be increased by the adoption of a tax rate of \$0.0109 for the Drainage Maintenance & Operation Fund and \$0.0020 for the Drainage Interest & Sinking Fund for a total Drainage Tax Rate of \$0.0129, which is effectively a 6.89 percent increase in the tax rate.
