FIRST AMENDMENT TO TAX ABATEMENT AGREEMENT BETWEEN
FORT BEND COUNTY DRAINAGE DISTRICT, DAIRY ASHFORD ENTERPRISE, INC., AND
BLUEBONNET NUTRACEUTICALS, LTD,

CITY OF SUGAR LAND REINVESTMENT ZONE 2021-01 (TO ASSIGN BLUEBONNET NUTRACEUTICALS, <u>LTD</u> TO BLUEBONNET NUTRITION <u>CORPORATION</u>)

This First AMENDMENT of the Tax Abatement Agreement is made and entered into by and between Fort Bend County Drainage District (hereinafter referred to as "District"), a body politic, acting herein by and through its Board of Directors and DAIRY ASHFORD ENTERPRISE, INC., (referred to as "Owner/Lessor,") BLUEBONNET NUTRACEUTICALS, LTD, (then referred to as Owner/"Lessee"), and BLUEBONNET NUTRITION CORPORATION (will now be referred to as Owner/"Lessee" on execution of this First Amendment).

## RECITALS

WHEREAS, on or about January 11, 2022, FORT BEND COUNTY DRAINAGE DISTRICT, DAIRY ASHFORD ENTERPRISE, INC. and BLUEBONNET NUTRACEUTICALS, LTD entered into a Tax Abatement Agreement for Eligible Property located in CITY OF SUGAR LAND REINVESTMENT ZONE 2021-01 (hereinafter the "Agreement") which is incorporated by reference;

WHEREAS, the Agreement was executed as authorized by and in accordance with the Property Redevelopment and Tax Abatement Act, Chapter 312, Texas Property Tax Code, and the current Guidelines and Criteria for Granting Tax Abatements in Reinvestment Zones located in Fort Bend County Drainage District (hereinafter the "Guidelines and Criteria") and

WHEREAS, the Parties now desire to amend certain portions of the Agreement as allowed by Texas Tax Code Section 312.208 and Section VII of the Guidelines and Criteria; and

WHEREAS Notice for this Amended Agreement was provided as required by Texas Tax Code Sec. 312.207.

NOW THEREFORE, for and in consideration of the mutual benefits to be derived by the parties hereto, the Parties agree as follows:

- Any references in the Agreement to BLUEBONNET NUTRACEUTICALS, LTD shall mean and refer to BLUEBONNET NUTRITION CORPORATION as an Owner of Eligible Property located in CITY OF SUGAR LAND REINVESTMENT ZONE 2021-01 and subject to the Agreement.
- 2. The Agreement is amended to the effect that all duties, obligations, and responsibilities imposed upon BLUEBONNET NUTRACEUTICALS, LTD under the Agreement shall be

imposed upon BLUEBONNET NUTRITION CORPORATION and all agreements and representations made by BLUEBONNET NUTRACEUTICALS, LTD in the Agreement shall be the agreements and representations of BLUEBONNET NUTRITION CORPORATION. All duties, obligations, and responsibilities of DAIRY ASHFORD ENTERPRISE, INC. remain with DAIRY ASHFORD ENTERPRISE, INC

- 3. The representatives of BLUEBONNET NUTRACEUTICALS, LTD and BLUEBONNET NUTRITION CORPORATION whose signatures execute this First Amendment represent and warrant to District that they have the requisite authority to enter into the Agreement and First Amendment thereof.
- 4. The below change is now made to the Performance Measures Table in the Agreement:

- 8. The County's Director of Economic Opportunity & Development shall be included on all correspondence to and/or from District/County employees and officials relative to this project. Use of email at: <a href="mailto:carlos.guzman@fortbendcountytx.gov">carlos.guzman@fortbendcountytx.gov</a> is considered satisfaction of this requirement, but not a substitution for legal notice to County.
- 9. Any further amendments to this Agreement shall be in accordance with the most recently adopted Guidelines and Criteria for Granting Tax Abatements in Fort Bend County Drainage District. This requirement applies even if this Amendment was executed under a prior set of Guidelines and Criteria.
- 10. Except as modified herein, any prior executed document remain in full force and effect and has not been modified or amended. In the event of conflict, the contents of this First Amendment shall prevail.
