WHEREAS, the parties executed and accepted that certain Agreement for Contingency All Hazards Consulting Services on July 9, 2019, (hereinafter “Agreement”), as amended by document executed on July 6, 2021, (hereinafter “Amendment”) pursuant to RFP 19-041; and

WHEREAS, the parties desire to further amend the Agreement to extend the Time of Performance under the Agreement.

NOW, THEREFORE, the parties do mutually agree the Time of Performance for the provision of Services under the Agreement, as extended under the Amendment, shall end no later than March 31, 2022.


Except as provided herein, all terms and conditions of the Agreement and the Amendment shall remain unchanged.
