**AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL ENGINEERING SERVICES**

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and iGET Services, LLC, (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on July 6, 2021, (hereinafter "Agreement") pursuant to SOQ 14-025; and

WHEREAS, the parties desire to amend the Agreement for additional services to be provided and increase the total Maximum Compensation under the Agreement for the completion of such additional services.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Contractor an additional thirty-four thousand seven hundred eleven dollars and no/100 (\$34,711.00), for the services as described in Contractor's proposal dated November 3, 2021, attached hereto as Exhibit "A" and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed five hundred eighty-eight thousand two dollars and 53/100 (\$588,002.53), authorized as follows:
 \$553,291.53 under the Agreement; and
 \$34,711.00 under this Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties.
4. BY ACCEPTANCE OF AGREEMENT, CONTRACTOR ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.



This has reference to the **FBC P.O. No: 201709** for the subject project, and the budget authorization approved in the Commissioners Court Meeting dated July 6th, 2021, for an NTE amount of **\$553,291.53**.

At this time, we are requesting the County to amend the Authorization for adding funds for the Services under the following line items: 210 – Collect Existing Data, and 220 - Conduct Field Reconnaissance:

210 - Collect Existing Data – Per iGET proposal dated June 08, 2021, an amount of \$24,031 was already authorized to cover this activity, for the line-item 210. This authorized amount was inadvertently left out in the Total Budget Amount Requested.

220 - Conduct Field Reconnaissance – Per iGET proposal dated June 08, 2021, an amount of \$10,680 was already authorized to cover this activity, for the line-item 220. This authorized amount was inadvertently left out in the Total Budget Amount Requested.

iGET is requesting to Amend the Authorized funds to add an Additional amount of **\$34,711.00** to increase the Total Authorized Budget from **\$553,291.53** to **\$588,002.53** with the following cost break-down:
