

RESTATED AND AMENDED ORDER APPOINTING COMMITTEE  
THOMPSON'S CHAPEL CEMETERY, KUYKENDALL CEMETARY, AND OTHER HISTORICAL  
CEMETERIES IN FORT BEND COUNTY

WHEREAS, Fort Bend County has received a request for maintenance and historic preservation of one or more historic cemeteries;

WHEREAS, Texas Health and Safety Code Section 713.028 allows a county to consider such requests; and

WHEREAS, the Commissioners Court of Fort Bend County, Texas has determined that the appointment of a committee to study Thompson's Chapel Cemetery (State of Texas Historical Identification FB-C125), the location named in the request, would assist the County in evaluating the request and developing a proposed course of action.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Commissioners' Court:

1. A committee of nine (9) individuals that are county representatives and community stakeholders shall be convened, as appointed by the County Judge (four appointees), Precinct 4 Commissioner (three appointees), and County Attorney (two appointees).
2. The committee is advisory in nature without control or supervision over public business or policy.
3. The purpose of the committee is to investigate, research, and make recommendations to the County regarding but not limited to the historical Thompson Chapel cemetery and the second cemetery property located off 99 Grand Parkway adjacent to the New Territory Subdivision baseball fields and the Kuykendall Cemetery, and any other burial/cemetery site to be evaluated for consideration of County support and/or maintenance.
4. The committee's investigation, research, and recommendations shall include but not be limited to the following:
  - a. Pictures of the site
  - b. Deeds or other evidence of ownership
  - c. Reports from health authorities as to health risks
  - d. Reports from historical organizations as to the significance of the cemetery
  - e. Reports of the approximate number of remains buried in said areas using available technology
  - f. Indications that any discriminatory practices reflected in the past have been cured.
  - g. Evaluation of maintenance needs

5. The Committee shall meet to discuss findings and provide a written report to the Court within 60 days of the information and evidence gathered and possible recommendations to the County and/or request an extension of time not to exceed another 45 days for the Committee to complete the foregoing tasks.

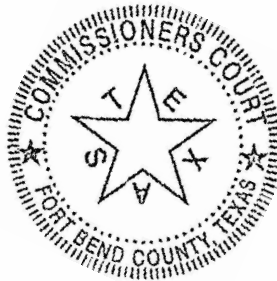
