Service Awards were presented to Commissioner Vincent Morales for 5 years of service and Commissioner Andy Meyers for 25 years of service.

Dr. Jacquelyn Minter, Director of Health & Human Services gave an update on COVID-19. There has been a decline in the number of COVID cases and hospitalizations in the Greater Houston Region. The new daily cases per day is 942, which are laboratory confirmed cases. Hospitalizations due to COVID are slowly declining; however, ICU cases have increased to 29%. The testing demand has decreased and response will be adjusted accordingly. It is hopeful with so many tools available, the worst effects of this pandemic may be behind us. Methods, such as masking, medication, prevention and staying educated and informed will help to protect our family, friends and neighbors against COVID-19.
