**AMENDMENT TO INFOR (US), LLC'S SUBSCRIPTION LICENSE
AND SERVICES AGREEMENT**

THIS AMENDMENT ("Amendment") is entered into by and between Fort Bend County, ("County"), a body corporate and politic under the laws of the State of Texas, and Infor (US), LLC, ("Infor"), a company authorized to conduct business in the State of Texas (collectively referred to as the "parties").

WITNESSETH:

WHEREAS, the parties previously entered into the Subscription License and Services Agreement on or about October 23, 2015, (hereinafter collectively referred to as "Agreement"), incorporated by reference as if set forth verbatim. County and Infor desire to amend said Agreement as set forth below:

I. Amendments

1. **Scope of Services.** Infor shall continue to provide Subscription Services as described in Infor's Invoice (P – 419349-US0AB) and the Order Form, incorporated by reference as if set forth verbatim.
2. **Term.** This Agreement shall renew and this Amendment is effective as of November 13, 2021, and shall expire no later than November 12, 2022, unless terminated sooner pursuant to the Agreement.
3. **Limit of Appropriation.** Infor's fees shall be calculated at the rates set forth in the attached Exhibit. The Maximum Compensation for the Subscription Services during the renewal term is Three Hundred Thirty-Seven Two Hundred Ninety and 60/100 dollars (**\$337,290.60**). Unless mutually agreed by the parties pursuant to a written agreement, in no case shall the amount paid by County under this Agreement exceed the Maximum Compensation without an approved change order. Infor clearly understands and agrees, such understanding and agreement being of the absolute essence of this Agreement, that County shall have available the total maximum sum of Three Hundred Thirty-Seven Two Hundred Ninety and 60/100 dollars (**\$337,290.60**), specifically allocated to fully discharge any and all liabilities County may incur. Infor does further understand and agree, said understanding and agreement also being of the absolute essence of this Agreement, that the total maximum compensation that Infor may become entitled to and the total maximum sum that County may become liable to pay to Infor shall not under any conditions, circumstances, or interpretations thereof exceed Three Hundred Thirty-Seven Two Hundred Ninety and 60/100 dollars (**\$337,290.60**).

4. **Modifications.** Except as modified herein, the Agreement remains in full force and effect and has not been modified or amended.
5. **Conflict.** If there is a conflict among documents, the most recently executed document will prevail with regard to the conflict.
6. **Human Trafficking.** BY ACCEPTANCE OF CONTRACT, INFOR ACKNOWLEDGES THAT FORT BEND COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.
7. **Certain State Law Requirements for Contracts.** The contents of this Section are required by Texas Law and are included by County regardless of content.
 - a. Agreement to Not Boycott Israel Chapter 2271 Texas Government Code: By signature below, Infor verifies Infor does not boycott Israel and will not boycott Israel during the term of this Agreement.
 - b. Texas Government Code § 2252.152 Acknowledgment: By signature below, Infor represents pursuant to § 2252.152 of the Texas Government Code, that Infor is not listed on the website of the Comptroller of the State of Texas concerning the listing of companies that are identified under § 806.051, § 807.051, or § 2252.153.
8. **Understanding, Fair Construction.** By execution of this Amendment, the parties acknowledge that they have read and understood each provision, term and obligation contained in this Amendment. This Amendment, although drawn by one party, shall be construed fairly and reasonably and not more strictly against the drafting party than the nondrafting party.

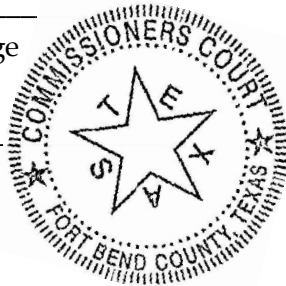
