### SECOND AMENDMENT TO AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES

**THIS SECOND AMENDMENT**, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and BGE, Inc. (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on June 4, 2019 pursuant to SOQ 14-025, (hereinafter "Agreement"), as amended by document executed on July 28, 2020, (hereinafter "Amendment"); and

WHEREAS, the parties desire to further amend the Agreement to allow Contractor to provide additional Services under the Agreement.

#### **NOW, THEREFORE,** the parties do mutually agree as follows:

- 1. County shall pay Contractor an additional amount not to exceed twenty-six thousand nine hundred eighty dollars and 60/100 (\$26,980.60) to perform the additional Services, as described in Contractor's proposal dated December 6, 2021 attached hereto as Exhibit "A" and incorporated herein for all purposes.
- 2. The Maximum Compensation payable to Contractor for all Services rendered is hereby increased to an amount not to exceed three hundred six thousand two hundred eighty-seven dollars and 63/100 (\$306,287.63), authorized as follows:

\$236,957.85 under the Agreement; \$42,349.18 under the Amendment; and \$26,980.60 under this Second Amendment.

- 3. In no case shall the amount paid by County for all Services under the Agreement and any subsequently executed amendment exceed the Maximum Compensation without further agreement executed by the parties.
- 4. BY ACCEPTANCE OF AGREEMENT, CONTRACTOR ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement and any subsequently executed amendment shall remain unchanged.

## 2017 Mobility Bond Program Scope of Services (BGE, Inc.) Supplemental Agreement No. 2

<u>Scope of Work</u> – the project generally includes roadway and intersection reconstruction, turn lane construction, signal modification or construction, drainage improvements, signing, striping, and SWPPP for the following project locations:

- Project 4-04 (Voss Rd. at SH 6): Proposed right turn lane and existing signal modification at the intersection of Voss Rd. at SH 6. Construct right turn lane from eastbound Voss Rd. to southbound SH 6. ROW acquisition is anticipated.
- 2. **Project 4-13 (Voss Rd at Old Richmond Rd)**: Proposed 2-lane roundabout at the intersection of Voss Rd & Old Richmond Rd. Rework roadway connection at each end of the roundabout.

<u>Scope of Services</u> – the Engineer (Design Consultant) shall perform supplemental design phase services according to the following detailed scope.

Project 4-13 – perform additional design phase survey to recover an existing manhole and modified alignment for an existing storm sewer trunk that was discovered on as-built plans provided by Fort Bend County. Revise the proposed storm sewer calculations, design, plans and update the bid package to incorporate the new storm sewer elements.

#### **FINAL DESIGN**

#### Survey

Perform field work and survey to recover an existing storm sewer manhole and modified alignment for an existing storm sewer trunk that was found on as-builts within the intersection of Old Richmond Rd. and Voss Rd.

#### **Drainage Design**

Drainage and Storm Sewer Designs – prepare updated drainage areas, hydrologic computations, storm sewer hydraulic computations, for revised storm sewers at Project 4-13: Voss Rd & Old Richmond Rd.
