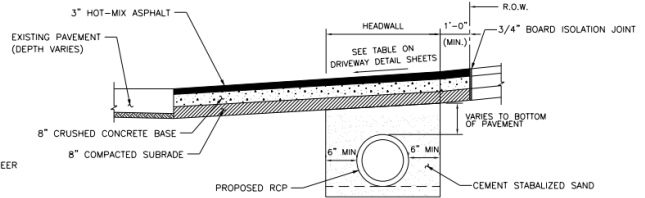


OPEN DITCH DRIVEWAY

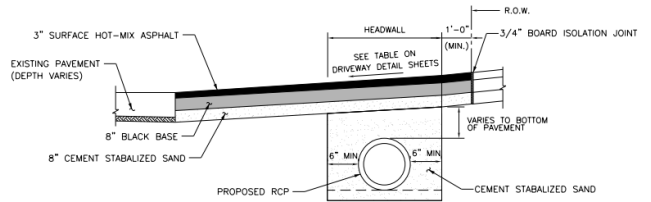

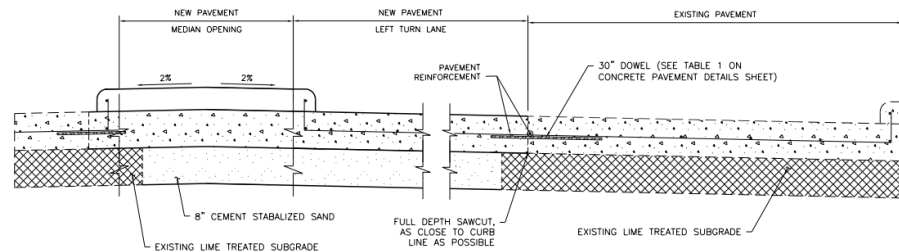
