THIRD AMENDMENT TO AGREEMENT FOR TRANSPORTATION SERVICES WITH FORT BEND SENIORS

THIS THIRD AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Fort Bend Seniors Meals on Wheels & Much, Much, More (hereinafter "FBS").

WHEREAS, the parties have executed and accepted that certain Agreement for Transportation Services with Fort Bend Seniors (the "Agreement"), on or about January 29, 2019, and as amended on August 25, 2020 and March 2, 2021; and

WHEREAS, the following changes are incorporated as if a part of the original Agreement incorporated by reference in the same as if fully set forth verbatim herein;

NOW, THEREFORE, the parties do mutually agree as follows:

1. The rates described in the Scope of Services shall be increased as described in the attached Exhibit A "Rate Schedule".

Except as provided herein, all terms and conditions of the Agreement, including any addenda or amendments, not modified shall remain in full force and effect. If there is a conflict between this Third Amendment and the Agreement, the provisions of this Third Amendment shall prevail with regard to the conflict.
