THIRD AMENDMENT OF AGREEMENT FOR PROFESSIONAL TITLE REPORT SERVICES

WHEREAS, the Maximum Compensation for the performance of services was previously increased to \$125,000.00 by that certain First Amendment of Agreement for Professional Title Report Services;

WHEREAS, the Maximum Compensation for the performance of services was previously increased to \$205,000.00 by that certain Second Amendment of Agreement for Professional Title Report Services.

County and Contractor hereby agree to increase the Maximum Compensation for the performance of Services within the Scope of Services as described in the Original Agreement to \$285,000.00.

County and Contractor hereby agree to amend Section 4 of the Original Agreement so that the total maximum compensation that Contractor may become entitled to and the total maximum sum that County may become liable to pay the Contractor is hereby increased to \$285,000.00.
