To the registered voters of the County of Fort Bend, Texas:

Notice is hereby given that an election shall be held in the County on the 7th day of May, 2022, in which all resident, qualified electors of the County shall be entitled to vote for in a special election to adopt or reject the proposed Constitutional Amendments as

submitted by the 87th Legislature, Third Called Session, of the State of Texas and for voters living within the territory of the proposed Fort Bend County Emergency Services District No. 9 to vote to approve, or disapprove, the creation of the proposed Emergency Services District No. 9 and the levy of a tax not to exceed Ten (10) cents on the one hundred (\$100.00) valuation. The polls shall be open for voting at such election from 7:00 a.m. to 7:00 p.m. Fort Bend County has adopted a countywide polling place program allowing voting at any election day polling location, and the election shall be conducted at each polling place, respectively, by the officers previously appointed by order of the Commissioners Court. The listing of polling places for May 7, 2022 is made a part hereof for all purposes.


