**AMENDMENT TO ADDENDUM TO AXON ENTERPRISE INC.'S AGREEMENT FOR PUBLIC SAFETY VIDEO SURVEILLANCE SOLUTIONS WITH RELATED EQUIPMENT, SOFTWARE AND ACCESSORIES (Sourcewell Contract #010720-AXN)**

THIS AMENDMENT ("Amendment") is entered into by and between Fort Bend County, ("County"), a body corporate and politic under the laws of the State of Texas, and Axon Enterprise, Inc., ("Axon"), a company authorized to conduct business in the State of Texas (collectively referred to as the "parties").

WITNESSETH:

WHEREAS, the parties previously entered into the Addendum to Axon Enterprise Inc.'s Agreement for Public Safety Video Surveillance Solutions with Related Equipment, Software, and Accessories on or about November 23, 2021, (the "Agreement"), incorporated fully by reference as if set forth verbatim below; and

WHEREAS, County desires to purchase additional product and/or services from Axon; and

WHEREAS, Axon represents that it is qualified and desires to provide additional product and/or services to County; and

WHEREAS, the parties wish to utilize Sourcewell Contract #010720-AXN, incorporated fully by reference, for the purchase of the additional product and/or services; and

Now, therefore, County and Axon desire to amend the Agreement as set forth below:

I.       Amendments

1. **Scope of Services.** Axon shall provide additional product and/or services, (collectively the "Services") to County as described in Axon's Quote #Q-374408-44622.842MP, attached as Exhibit "1" and incorporated fully by reference; and in accordance with the requirements and specifications of Sourcewell Contract # 010720-AXN.
2. **Limit of Appropriation.** Axon's fees shall be calculated at the rates set forth in the attached Exhibit 1. The Limit of Appropriation for the performance of Services within the Scope of Services as described in Exhibit 1 is \$2,248,994.48. The Limit of Appropriation payable to Axon for product and/or services rendered under the Agreement is hereby increased to an amount not to exceed \$24,334,569.48, authorized as follows:

\$22,085,574.99 under the Agreement; and  
 \$2,248,994.48 under this Amendment to the Agreement

In no case shall the amount paid by County for all product and/or services under the Agreement and this Amendment to the Agreement exceed the above Limit of Appropriation without an agreement executed by the parties.

3. **Payment; Non-appropriation; Taxes.** County Axon shall submit to County one (1) original invoice for approval and processing to 301 Jackson Street, Suite 701, Richmond, Texas 77469 and one (1) electronic copy to County, in the amount for each applicable month listed in the Payment Summary Section of Exhibit 1. The invoices will show the amounts due for Services performed and will be in a form acceptable to County. Payment shall be made by County within thirty (30) days of receipt of invoices. If County disputes charges related to the invoice(s) submitted by Axon, County shall notify Axon no later than twenty-one (21) days after the date County receives the invoice(s). It is specifically understood and agreed that in the event no funds or insufficient funds are appropriated by Fort Bend County under this Agreement, Fort Bend County shall notify all necessary parties that this Agreement shall thereafter terminate and be null and void on the last day of the fiscal period for which appropriations were made without penalty, liability or expense to Fort Bend County. County is a body corporate and politic under the laws of the State of Texas and claims exemption from sales and use taxes. A copy of a tax-exempt certificate will be furnished upon request. Interest resulting from late payments by County shall be governed by Chapter 2251, TEXAS GOVERNMENT CODE. County reserves the right to withhold payment pending verification of satisfactory work performed.

Mutually approved travel and mileage expenses incurred in the performance of required Services will be compensated only in accordance with the County's Travel Policy, a copy of which will be provided upon request. Receipts evidencing travel related expenditures made by Axon or Axon's subcontractors shall be submitted to the County Auditor's Office:

4. **Modifications.** Except as modified herein, the Agreement remains in full force and effect and has not been modified or amended.
5. **Conflict.** If there is a conflict among documents, the most recently executed document will prevail with regard to the conflict.
6. **Understanding, Fair Construction.** By execution of this Amendment, the parties acknowledge that they have read and understood each provision, term and obligation contained in this Amendment. This Amendment, although drawn by one party, shall be construed fairly and reasonably and not more strictly against the drafting party than the nondrafting party.
7. **Severability.** If any provision of this Agreement is determined to be invalid, illegal, or unenforceable, the remaining provisions remain in full force, if the essential terms and conditions of this Agreement for each party remain valid, binding, and enforceable.

IN WITNESS WHEREOF, this Amendment is signed, accepted, and agreed to by all parties by and through the parties or their agents or authorized representatives. All parties hereby acknowledge that they have read and understood this Amendment and the attachments and exhibits hereto. All parties further acknowledge that they have executed this legal document voluntarily and of their own free will. This Amendment shall become effective upon execution of both parties.

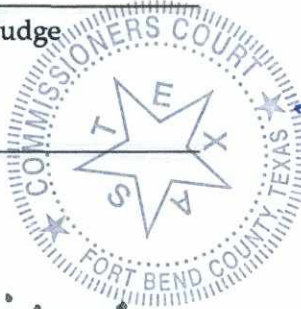
