## FIRST AMENDMENT TO TAX ABATEMENT AGREEMENT BETWEEN FORT BEND COUNTY AND TDC-DRI SUGAR LAND, LLC (TO ASSIGN TO EVOX TX SUGAR LAND 12510, LLC)

This First Amendment of the Tax Abatement Agreement is made and entered into by and between FORT BEND COUNTY, TEXAS, (hereinafter referred to as "County") a body politic, acting herein by and through its Commissioners Court and TDC-DRI SUGAR LAND, LLC, (may also hereinafter be referred to as "Former Owner/Assignor"), and EVOX TX SUGAR LAND 12510, LLC (may also hereinafter be referred to as "Assignee/New Owner.").

WHEREAS, County and Former Owner/Assignor, TDI-DRI SUGAR LAND, LLC entered into a Tax Abatement Agreement on or about January 20, 2020, (hereinafter the "Agreement"); and

WHEREAS, Former Owner/Assignor desires to transfer its interest as the former Owner of the real property and improvements subject to the Agreement and assign all of its rights, interest and obligations as Former Owner/Assignor of the real property under the Agreement to the New Owner/Assignee; and

**WHEREAS**, the parties desire to amend the Agreement to reflect such Assignment of the Agreement.

**NOW THEREFORE,** for and in consideration of the mutual benefits to be derived by the parties hereto, County, Former Owner/Assignor and New Owner/Assignee agree as follows:

Pursuant to and in accordance with the Property Redevelopment and Tax Abatement Act, Chapter 312, Texas Property Tax Code, and the Guidelines and Criteria for Granting Tax Abatements in Reinvestment Zones located in Fort Bend County, Texas, the Agreement is hereby amended as follows:

- Any references in the Agreement to "Owner" shall mean and refer to EVOX TX SUGAR LAND 12510, LLC, as the owner of the real property and improvements subject to the Agreement located in Reinvestment Zone No. 17 created by the City of Missouri City, Texas.
- The Agreement is amended to the effect that all duties, obligations, and responsibilities imposed upon Owner under the Agreement shall be imposed upon EVOX TX SUGAR LAND 12510, LLC, and all agreements and representations made by Owner in the Agreement shall be the agreements and representations of EVOX TX SUGAR LAND 12510, LLC.
- 3. The representatives of Former/Owner/Assignor and New Owner/Assignee whose signatures execute this First Amendment represent and warrant to Fort Bend

County that they have the requisite authority to enter into the Agreement and First Amendment thereof.

- 5. EVOX TX SUGAR LAND 12510, LLC, SHALL BE RESPONSIBLE FOR NOTIFYING THE COUNTY OF THE ABATEMENT, INCLUDING FILING WITH THE COUNTY ANY APPLICATION OR OTHER FORMS NECESSARY TO QUALIFY FOR OR RECEIVE THE ABATEMENT GRANTED.
- 6. Except as modified herein, the above referenced Agreement remains in full force and effect and has not been modified or amended.
- 7. The Tax Abatement shall apply for the tax years as stated in the Agreement. This Amendment does not purport to extend the tax abatement to tax years beyond tax year 2024, as stated in the original agreement.
- 8. All future Amendments, if any, of the Agreement shall require written consent of the County and shall be had in accordance with the Guidelines and Criteria for Granting Tax Abatements in Reinvestment Zones located in Fort Bend County, Texas adopted at the time the Amendment is requested.
- 9. The original Tax Abatement Agreement executed by and between Fort Bend County and TDI-DRI SUGAR LAND, LLC, is hereby adopted by EVOX TX SUGAR LAND 12510, LLC, and incorporated by reference the same as if fully set forth verbatim herein for all purposes, subject only to the above described amendments.
