## AMENDMENT TO AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES

**THIS AMENDMENT**, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Kavi Consulting, Inc., (hereinafter "Consultant"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on October 26, 2021, (hereinafter "Agreement") pursuant to SOQ 14-025; and

WHEREAS, the parties desire to amend the Agreement for additional services to be provided and increase the total Maximum Compensation under the Agreement for the completion of such additional services.

### **NOW, THEREFORE,** the parties do mutually agree as follows:

- County shall pay Consultant an additional eleven thousand four hundred seventy-five dollars and no/100 (\$11,475.00), for the services as described in Consultant's proposal dated December 29, 2021, attached hereto as Exhibit "A" and incorporated herein for all purposes.
- 2. The Maximum Compensation payable to Consultant for Services rendered is hereby increased to an amount not to exceed one hundred eighty-eight thousand four hundred forty dollars and no/100 (\$188,440.00), authorized as follows:

\$176,965.00 under the Agreement; and \$11,475.00 under this Amendment.

- 3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties.
- 4. BY ACCEPTANCE OF AGREEMENT, CONSULTANT ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.
