THIRD AMENDMENT TO AGREEMENT FOR PROFESSIONAL CONSTRUCTION MANAGEMENT SERVICES FORT BEND COUNTY WESTPARK PARK AND RIDE RFQ 19-020

THIS THIRD AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Huitt-Zollars, Inc. (hereinafter "Consultant"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties have executed and accepted that certain Agreement for Professional Construction Management Services (the "Agreement"), on or about October 1, 2019, and as amended on October 22, 2019 and September 1, 2020; and

WHEREAS, the following changes are incorporated as if a part of the original Agreement incorporated by reference in the same as if fully set forth verbatim herein;

NOW, THEREFORE, the parties do mutually agree as follows:

- 1. **Time of Performance.** The time for performance of the Services shall be extended for an additional period of time ending on December 31, 2023.
- Additional State Law Requirements for Contracts. The contents of this Section are required by Texas Law and are included by County regardless of content.
 - a. If employing ten (10) or more full-time employees and this Agreement has a value of \$100,000.00 or more, Contractor does not boycott energy companies and is authorized to agree in such contracts not to boycott energy companies during the term of such contracts. "Boycott energy company" has the meaning provided in section 809.001 of the Texas Government Code.
 - b. If employing ten (10) or more full-time employees and this Agreement has a value of \$100,000.00 or more, Contractor does not have a practice, policy, guidance, or directive that discriminates against a firearm entity or firearm trade association and is authorized to agree in such contracts not to discriminate against a firearm entity or firearm trade association during the term of such contracts. "Discriminate against a firearm entity or firearm trade association" has the meaning provided in section 2274.001(3) of the Texas Government Code. "Firearm entity" and "firearm

trade association" have the meanings provided in section 2274.001(6) and (7) of the Texas Government Code.

There shall be no changes in the Maximum Compensation paid by the County for the Scope of Services.

Except as provided herein, all terms and conditions of the Agreement, including any addenda or amendments, not modified shall remain in full force and effect. If there is a conflict between this Third Amendment and the Agreement, the provisions of this Third Amendment shall prevail with regard to the conflict.
