AMENDMENT TO AGREEMENT FOR PROFESSIONAL ENVIRONMENTAL SERVICES

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Berg-Oliver Associates, Inc. (hereinafter "Consultant"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Environmental Services on January 7, 2020 pursuant to SOQ 14-025, (hereinafter "Agreement"); and

WHEREAS, the parties desire to amend the Agreement to allow Consultant to provide additional Services and extend the Time of Performance under the Agreement.

NOW, THEREFORE, the parties do mutually agree as follows:

- 1. County shall pay Consultant an additional amount not to exceed eighty-five thousand one hundred twenty-one dollars and 20/100 (\$85,121.20) to perform the additional Services, as described in Consultant's proposal dated February 28, 2022 attached hereto as Exhibit "A" and incorporated herein for all purposes.
- 2. The Maximum Compensation payable to Consultant for all Services rendered is hereby increased to an amount not to exceed two hundred seventy-three thousand forty-eight dollars and 90/100 (\$273,048.90), authorized as follows:

\$187,927.70 under the Agreement; and \$85,121.20 under this Amendment.

- 3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without an agreement executed by the parties.
- 4. The Time of Performance under the Agreement is hereby extended to end no later than December 31, 2026.
- 5. BY ACCEPTANCE OF AGREEMENT, CONSULTANT ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

ADDENDUM TO CONTRACT

The following is an addendum to an original agreement made between the following parties:

This addendum requests supplemental budget generally for the following: additional Project Management/Right-of-Entry (ROE), Environmental Setting & Evaluation, and the Public Meeting (held virtually in June 2021). In addition, a new 2nd public involvement event appears to be required by TxDOT.

Berg Oliver requests additional budget to continue with environmental project services and proposes a new *additional* service to FBCED on an hourly basis, not to exceed the totals in the table below.

^{*} Please note that if the ICI Analysis (Task 7) is NOT required, then the \$17,072.80 proposed for that task could partially cover this supplemental budget request and reduce the request to \$68,048.40. ICI analysis is currently not required by TxDOT for CE projects; however, since TxDOT policies change periodically, it is assumed that Task 7 could be needed before this project is approved.

These requests are explained below:

• Task 1 — PM/ROE — Initially the project included very little additional ROW along the roadway (i.e., only at a few intersections where turning lanes would be needed). The amount of road ROW increased significantly, which led to a more involved, longer ROE process and more project management. Also, the project's addition of railroad bridge alternatives led to additional project management and schematic discussion/review.

- Task 2 Environmental Setting & Evaluation The additional ROW required additional field work, mapping and report preparation for the Wetland Delineation and Biological Studies.
- Task 11 Public Meeting The initial scope included one 'normal' (in-person) public meeting. However, due to the pandemic, TxDOT required a Virtual Public Meeting instead. This was a new process that required substantial coordination and preparation of a presentation (typically only prepared for public hearings), including Spanish translation and narration/video production. In addition, the railroad bridge alternatives added some additional efforts. This task exceeded the contracted budget. Please note that BOA was able to utilize the unused budget from Task 4 (NOC) to cover some of that expense; NOC is not needed when you conduct a public meeting.
- Task 12 (NEW) Virtual Public Hearing w/ In-Person Option The initial scope included one public meeting. With the project including bridge <u>alternatives</u> at the railroad, TxDOT is requesting a second public involvement event to present the selected alternative. At this time, it has not been decided if that would be a Virtual Public Meeting or Hearing; either would likely have an In-Person Option.

The total of the charges for the additional work will not exceed the following total without written approval from the client:

Eighty-Five Thousand, One Hundred Twenty-One and Twenty Hundredths Dollars (\$85,121.20)

Berg Oliver and Horizon will begin the work described herein upon the execution of this addendum by the client. Invoices for all hourly work will be submitted monthly and will be based upon the attached Rate Schedule. Payment of all invoices is expected within thirty (30) days of the client's receipt of the invoice submitted by Berg Oliver Associates, Inc.

Upon execution of this addendum by the client below, Berg Oliver is authorized to proceed with the services described in this addendum to the original contract.
