This letter is to advise of a price increases needed for all items included in Bid 22-037. This price increase is due to increase in Urea stock prices occasioned by inflationary pressures in the market, and decreases in availability.

Here is the list of prices included in Bid 22-037, and the current/future price to FBC:

Original BID Price per gal bulk delivery FOB FFBC DEF: \$2.52/gal

Revised BID Price per gal bulk delivery FOB FFBC DEF: \$3.09/gal

Original Bid Price per 2-1/2 gal containers FOB FBC: \$9.78/each

Revised Bid Price per 2-1/2 gal containers FOB FBC: \$12.02/each

The price increases will be effective on all orders placed June 8<sup>th</sup>, 2022. Please find attached a PDF letter for notification of price increases by our supplier, notifying us of increases of Urea and raw material for blending Diesel Exhaust Fluid (DEF).
