**SECOND AMENDMENT TO ADDENDUM TO C&T INFORMATION
 TECHNOLOGY CONSULTING, INC.'S AGREEMENT
 FOR CONSULTING SERVICES CONCERNING REDISTRICTING EFFORTS
 (DIR CONTRACT NO. DIR-CPO-4570)**

THIS SECOND AMENDMENT is made and entered into by and between **FORT BEND COUNTY**, a body corporate and politic under the laws of the State of Texas, and **C&T INFORMATION TECHNOLOGY CONSULTING, INC.**, (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, on or about January 4, 2022, the Parties entered into *Addendum to C&T Information Technology Consulting, Inc.'s Agreement for Consulting Services concerning Redistricting Efforts (DIR Contract No. DIR-CPO-4570*, and as last amended on June 14, 2022, (hereinafter "Agreement") which is incorporated by reference as if set forth herein verbatim; and

WHEREAS, the parties desire to amend the Agreement to increase the Total Maximum Compensation under the Agreement for the completion of such additional services to be provided thereunder;

NOW THEREFORE, in consideration of the mutual covenants and conditions set forth below, the parties agree:

1. **Scope of Services.** Subject to this Amendment, Contractor will render additional Services in the form of building a secure web application and services as defined in Exhibit A attached hereto and incorporated by reference.
2. County shall pay Contractor an additional twenty-three thousand six hundred and 0/100 dollars (\$23,600.00) to continue providing Services under the terms and conditions of the Agreement.
3. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed three hundred thirteen thousand six hundred sixteen and 0/100 dollars (\$313,616.00), authorized as follows:

\$290,016.00 under the Agreement; and
 \$23,600.00 under this Amendment.

4. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties.
5. The parties agree the terms and conditions of the Agreement have remained in effect to date.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.
