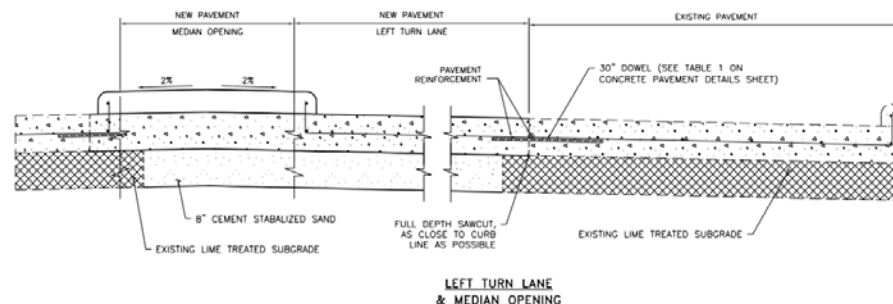
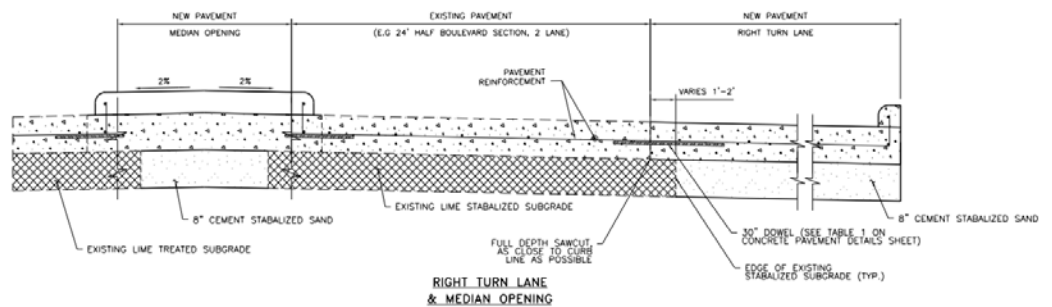
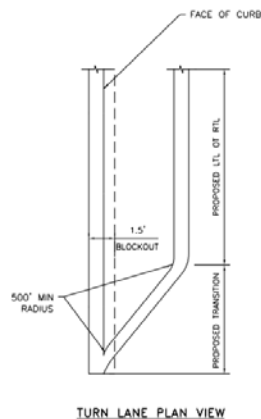
ASPHALT APRON DETAIL – DRIVEWAY PROFILE
