 across and/or along roads, streets and highways in the County of Fort Bend, and the State of Texas, under the
 jurisdiction of the Commissioners' Court of Fort Bend County, Texas, pursuant to the Commissioners' Court
 order adopted on the 1st day of December, A.D. 1980, recorded in Volume 13, of the Commissioners' Court
 Minutes of Fort Bend County, Texas, regulating same, which Commissioners' Court order is hereby referred to
 and made a part hereof for all purposes as though fully set out herein.

AND WHEREAS, the principal desires to provide Fort Bend County with a perpetual bond covering all
 such cable, conduit and/or pole line activity;

NOW, THEREFORE, if the above bounden principal shall faithfully perform all its cable, conduit and/or
 pole line activity (including, but not limited to the laying, constructing, maintaining and/or repair of cables,
 conduits and/or pole lines) in, under, across and/or along roads, streets and highways in the County of Fort Bend
 and State of Texas, under the jurisdiction of the Commissioners Court of Fort Bend County, Texas, pursuant
 to and in accordance with minimum requirements and conditions of the above mentioned Commissioners'
 Court order set forth and specified to be by said principal done and performed, at the time and in the manner
 therein specified, and shall pay over and make good and reimburse Fort Bend County, all loss and damages
 which Fort Bend County may sustain by reason of any failure or default on the part of said principal, then this
 obligation shall be null and void otherwise to remain in full force and effect.

This bond is payable at the County Courthouse in the County of Fort Bend and State of Texas.

It is understood that at any time Fort Bend County deems itself insecure under this bond, it may
 require further and/or additional bonds of the principal.

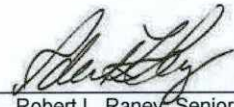

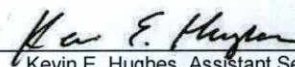
