4. Public Comments regarding the Agenda and Announcements.

Judge George announced two new staff members in his office, Ryan Dunsmore, Multimedia Communications & Project Manager and Danielle Saldua, Administrative and External Affairs Manager.

The Summer Internship Program is ending and a farewell celebration will be held on Friday, July 29, 2022, 3:00 p.m. – 5:00 p.m. at the Hampton Inn and Suites in Sugar Land.

Dr. Jacquelyn Minter, Director of Health & Human Services gave an update on COVID in Fort Bend County. The impact of the current COVID variant BA5 in Fort Bend County has reflected what was experienced in the Northeastern U.S. earlier this year and the peak in cases just after July 4. Our local new active cases last week experienced a decrease. The local data for week ending July 24 indicates we have an average 191 active cases per one hundred thousand residents. There was an average of 12 new COVID-19 hospitalizations over the past 7 days. Approximately 6% of staffed hospital inpatient beds are occupied by COVID-19 patients. This local data means Fort Bend County is in the medium level for community impact. The CDC precautions for medium community impact are to stay up-to-date with COVID vaccines and boosters, get tested if you have symptoms, wear mask if you have symptoms or have been exposed and wear mask on public transportation. For those who are at high risk should consider wearing a mask indoors and take precautions. An additional public health concern is the emergence of the Monkey Pox virus. The first case in Fort Bend County was reported on July 14, 2022. Up-to-date information on the Monkey Pox can be accessed on the HHS webpage or by contacting the call center.

Judge George announced Fort Bend County will be holding its first Emergency Preparedness Meeting at the Cinco Ranch Library from 5:00 p.m. – 7:00 p.m. this evening.

The Summer Youth presented to the court a video of what was learned this summer and thanked Commissioners Court for giving them the opportunity to participate in this program. There were 239 students who participated in the Summer Youth Program in Fort Bend County.

Ryan Dunsmore, Multimedia Communications and Project Manager for the Office of the County Judge presented a Proclamation, on behalf of Commissioners Court, to Alan Spears, Emergency Management Coordinator on his Retirement and named July 26, 2022 as Alan Spears Day.

Mr. Dunsmore presented a Proclamation, on behalf of Commissioners Court, to Parks and Recreation which is an essential part in communities that promote health and wellness. The month of July 2022 has been proclaimed as Parks and Recreation month.

Mr. Dunsmore presented a Proclamation, on behalf of Commissioners Court, to YMCA of Greater Houston. The YMCA has been recognized for its dedication and commitment to providing summer programs for children.

Judge George announced that \$500 will be given to the YMCA. These funds are from a collection he receives when marrying people.
