

KNOW ALL MEN BY THESE PRESENTS:

THAT WE, Northtex Construction, LLC whose (address, phone) is 550 Greens Parkway, Suite 105, Houston, Texas 77067, Phone: (832) 409-5740 hereinafter called the Principal, and Great American Insurance Company, a Corporation existing under and by virtue of the laws of the state of Ohio and authorized to do an indemnifying business in the state of Texas, and whose principal office is located at (name/address/phone) 301 E.
