

KNOW ALL MEN BY THESE PRESENTS:

THAT WE, TACKLE CONSTRUCTION, INC. whose (address, phone) is P.O. 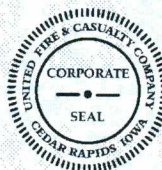
