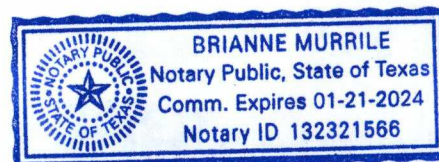

The proposed area to be designated as Fort Bend County Reinvestment Zone Number 1 encompasses approximately 4,075-acre tract and is generally bounded by FM 2218 to the north, FM 2977 to the south, Pleak Road on the west and north of Dry Creek to the east. It is in Fort Bend County, Texas (the "County") and within the extraterritorial jurisdiction of the Cities of Rosenberg, Pleak and Fairchilds (the "Cities"). The legal description and boundary map of the proposed Fort Bend County Reinvestment Zone Number One, Fort Bend County, Texas, are on file and open for public inspection in the office of the Fort Bend County Clerk at 301 Jackson St., Suite 101, Richmond, Texas.
