THIRD AMENDMENT TO AGREEMENT FOR RFP 21-042 TRANSPORTATION SERVICES OF DECEDENTS

THIS THIRD AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and **CARING TRANSPORTS LLC** (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain *Agreement For RFP 21-042 Transportation Services of Decedents* on March 23, 2021, which was amended on August 24, 2021, and later amended on January 11, 2022, (hereinafter collectively referred to as "Agreement") which is incorporated by reference as if set forth herein verbatim; and

WHEREAS, the Parties now desire to amend a certain portion of the Agreement; and

NOW, THEREFORE, the parties do mutually agree as follows:

- 1. **Term**. The Agreement shall be renewed for an additional one (1) year term beginning October 1, 2022 and shall terminate September 30, 2023.
- 2. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties.
- 3. This Amendment shall be effective as of the date signed by both Parties through the remainder of the term of the Agreement.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.
