**FIRST AMENDMENT TO AGREEMENT FOR PROCUREMENT SUPPORT AND TECHNICAL ASSISTANCE PURSUANT TO RFP 19-041 – CONTINGENCY ALL HAZARDS CONSULTING SERVICES**

**THIS AMENDMENT** is made and entered into by and between Fort Bend County, (hereinafter “County”), a body corporate and politic under the laws of the State of Texas, and Tetra Tech, Inc. (hereinafter “Consultant”), a company authorized to conduct business in the State of Texas.

**WHEREAS**, the parties executed and accepted that certain Agreement For Procurement Support and Technical Assistance Pursuant To FBC RFP 19-041 on January 4, 2022 and incorporated herein by reference as if set forth herein verbatim (collectively hereinafter “Agreement”);

**WHEREAS**, the parties desire to amend the Agreement to extend the Time of Performance;

**NOW, THEREFORE**, in consideration of the mutual covenants and conditions set forth below, the parties agree as follows:

1. The parties agree the terms and conditions of the Agreement have remained in effect to date and are hereby extended to end no later than March 31, 2023.
2. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.
