**SECOND AMENDMENT TO AGREEMENT FOR BULK FUEL
 BETWEEN FIKES WHOLESALE INC. AND FORT BEND COUNTY
 PURSUANT TO RFP 22-001
 RENEWAL**

THIS SECOND AMENDMENT is made and entered into by and between Fort Bend County, (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Fikes Wholesale Inc. (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas, hereinafter collectively referred to as the "Parties."

W I T N E S S E T H

WHEREAS, on or about September 22, 2021, the Parties previously executed the Agreement for Bulk Fuel Pursuant to RFP 22-001, which was amended on or about January 25, 2022; all of which are incorporated by reference; and

WHEREAS, the Parties now desire to amend the Agreement for an additional service year under the same terms and conditions as most recently executed by Parties.

NOW, THEREFORE, in consideration of the mutual covenants and conditions set forth below, the parties agree as follows:

1. The Agreement is hereby renewed; effective October 1, 2022 and through September 30, 2023. Terms, conditions, pricing and additional renewal periods shall remain the same.
2. Except as provided herein, all terms and conditions of the Agreement, including any previous Amendments and/or Addenda, remain in full force and effect. The Agreement, and its Executed Amendments are the sole and final agreement of the parties regarding the subject matter hereof, and supersede any previous agreements, understandings, and arrangements relating to such subject matter.


