**ORDER APPROVING CREATION OF THE FORT BEND COUNTY SECTION 115
 OBLIGATIONS FOR POST-EMPLOYMENT BENEFITS ("OPEB") TRUST**

The Commissioners Court of Fort Bend County, Texas, met in regular session at its regular term at the Fort Bend County Courthouse in the City of Richmond, Texas, on September 27, 2022, with a quorum of members present,

Among other business, the following was transacted:

Consideration of the creation of the Fort Bend County Section 115 Obligations for Post-employment Benefits ("OPEB") Trust by adopting the Post-Employment Benefits Trust Agreement between PFM Asset Management LLC ("PFM"), as Trust Administrator, and Principal Bank ("Principal Bank") as Trustee; authorizing the County Auditor and County Treasurer to execute the necessary documents and agreements to signify its adoption including, but not limited to, an Adoption Agreement and Trust Administrative Services Agreement; approving, ratifying and confirming the appointment of Principal Bank as the Trustee and PFM as the Trust Administrator as of the effective date of the Adoption Agreement and to have the County Judge to certify these actions.

Commissioner Meyers moved that Commissioners Court approve the action as presented.

Commissioner Prestage seconded the motion for approval of the action. The motion, carrying with it the approval and adoption of an order reflecting the action through a majority vote.

The County Judge thereupon announced that the motion had duly and lawfully carried and that an order had been duly and lawfully adopted. The order adopted follows:

IT IS ORDERED that Commissioners Court approves the creation of the Fort Bend County Section 115 OPEB Trust by:

- 1) Adopting the Post-Employment Benefits Trust Agreement between PFM Asset Management LLC ("PFM"), as Trust Administrator, and Principal Bank ("Principal Bank") as Trustee;
- 2) Authorizing the County Auditor and County Treasurer to execute the necessary documents and agreements to signify its adoption including, but

not limited to, an Adoption Agreement and Trust Administrative Services Agreement;

- 3) Approving, ratifying and confirming the appointment of Principal Bank as the Trustee and PFM as the Trust Administrator as of the effective date of the Adoption Agreement; and
- 4) To have the County Judge to certify these actions.
