**THIRD AMENDMENT TO  
 COMMISSARY MANAGEMENT SERVICES AGREEMENT PURSUANT TO RFP18-094**

THIS THIRD AMENDMENT is made and entered into by and between Fort Bend County, ("County"), a body corporate and politic under the laws of the State of Texas, and ARAMARK CORRECTIONAL SERVICES LLC, (hereinafter "Contractor") a company authorized to conduct business in the State of Texas.

WITNESSETH

WHEREAS, County and Contractor ("Parties") executed the Commissary Management Services Agreement Pursuant to RFP 18-094 on or about JANUARY 30, 2019 and amended on or about OCTOBER 19, 2020 and June 29, 2021 (collectively the "Agreement") which is incorporated by reference as if set forth herein verbatim; and

WHEREAS, the parties desire to further amend the Agreement to allow Contractor to provide additional Services under the Agreement.

NOW, THEREFORE, the parties do mutually agree as follows:

- A. The Agreement is hereby renewed; effective October 1, 2022 and shall terminate on September 30, 2023.
- B. Pricing under this Amendment shall be in accordance with pricing units listed in Exhibit A, attached hereto and incorporated by reference as if set forth herein verbatim.
- C. Except as modified herein, the Agreement remains in full force and effect and has not been modified or amended.
- D. If there is a conflict among documents, the most recently executed document will prevail with regards to the conflict.

**Amendment No. 3 to Commissary Management Services Agreement**

**THIS AMENDMENT NO. 3** (the “**Amendment**”), is entered into this \_\_\_\_ day of August, 2022 by and between Fort Bend County, (the “**County**”), a body corporate and politic under the laws of the State of Texas, and Aramark Correctional Services, LLC (“**Aramark**” or “**Contractor**”), a Delaware limited liability company authorized to conduct business in the State of Texas, having its principal place of business located at 2400 Market Street, Philadelphia, PA 19103.

**WHEREAS**, the parties entered into an Agreement dated January 30, 2019 for the management of the commissary services at the Fort Bend County Jail (the “**Agreement**”);

**WHEREAS**, the parties desire to extend the term of the Agreement;

**WHEREAS**, the parties acknowledge the need to address volatility in the cost of food commodities; and

**WHEREAS**, the parties desire to amend the provisions of the Agreement as follows, effective October 1, 2022.

**NOW, THEREFORE**, in consideration of the foregoing and of the mutual promises in the Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as set forth below. Capitalized terms used but not defined in this Amendment have the meanings ascribed to such terms in the Agreement.

1. **Term:** In accordance with Section 2.1 of the Agreement, the parties mutually agree that the term of the Agreement shall be extended from October 1, 2022 through September 30, 2023.
2. **Pricing:** The Product and Price Index attached to the Agreement as Exhibit A shall be amended as reflected on Attachment A.
3. **Effect of Amendment:** Except as specifically set forth herein, all other terms and provisions of the Agreement shall remain unaffected by this Amendment and shall continue in full force and effect.
