**AMENDMENT TO ADDENDUM TO  
 CONFERENCE TECHNOLOGIES INC.'S AGREEMENT**

**THIS AMENDMENT** is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Conference Technologies Inc., (hereinafter "Conference Technologies"), a company authorized to conduct business in the State of Texas (hereinafter collectively referred to as the "parties).

**WHEREAS**, the parties executed and accepted that certain *Addendum to Conference Technologies Inc.'s Agreement* on February 11, 2022, (hereinafter "Agreement"), pursuant to The Interlocal Purchasing System ("TIPS") Contract #200904 which are incorporated by reference as if set forth herein verbatim; and

**WHEREAS**, the parties desire to amend the Agreement to reflect the change in Services to be provided and increase the total Maximum Compensation under the Agreement.

**NOW, THEREFORE**, the parties do mutually agree as follows:

1. County shall pay Contractor an additional fifteen thousand one hundred seventy and 0/100 dollars (\$15,170.00) to perform the revised Services as described in the Change Order dated July 27, 2022 attached hereto as Exhibit "C" and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for all Services rendered is hereby increased to an amount not to exceed sixty thousand seven hundred seventy-eight and 01/100 (\$60,778.01).

3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without an agreement executed by the parties.
4. The parties agree the terms and conditions of the Agreement have remained in effect to date.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.


