AMENDMENT TO AGREEMENT FOR PROFESSIONAL ENVIRONMENTAL SERVICES

THIS AMENDMENT is made and entered into by and between Fort Bend County, ("County"), a body corporate and politic under the laws of the State of Texas, and MPACT Strategic Consulting, LLC ("Contractor"), a company authorized to conduct business in the State of Texas.

WITNESSETH

WHEREAS, the parties have executed and accepted that certain Agreement for environmental review and consulting services as required for various County improvement projects pursuant to SOQ 20-109 (the "Agreement"), on or about January 12, 2021; and

WHEREAS, the following changes are incorporated as if a part of the original Agreement incorporated by reference in the same as if fully set forth verbatim herein; and

WHEREAS, Contractor represents that it is still qualified and desires to perform such services.

NOW, THEREFORE, in consideration of the mutual covenants and conditions set forth in the Agreement and this Amendment, the parties agree as follows:

1. **Time of Performance**. This Amendment shall become effective immediately upon execution by the County and will continue in full effect until March 31, 2023.




