FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT

This FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT ("Amendment") is entered into this 21st day of November, 2022, by and between Fort Bend Grand Parkway Toll Road Authority and Fort Bend County Toll Road Authority (together, "Authorities") and James A. Thompson, d.b.a. Lucrum Investments, LLP ("Consultant," and together with "Authorities," "Parties").

BACKGROUND

The Authorities and the Consultant entered into an Agreement for Professional Services dated June 20, 2018 ("Agreement"), pursuant to which Consultant provides certain ongoing professional services to the Authorities. The Parties now wish to amend Section 4.a. of the Agreement to increase compensation for Consultant's Services effective as of January 1, 2023.

NOW, THEREFORE, for and in consideration of the promises and the mutual agreements set forth herein, Consultant and the Authorities agree as follows:

AGREEMENT

Section 4.a. of the Agreement is hereby deleted in its entirety and replaced with the following:

"a. In consideration for the Services to be performed by Consultant, the Authorities will compensate Consultant for the Services at the combined rate of \$7,300 per month."

Except as amended hereby, all terms and provisions of the Agreement, including Section 4.b. thereof, shall remain in full force and effect. Terms not defined in this Amendment shall have the meanings provided in the Agreement.
