

**SUPPLEMENTAL AGREEMENT NO. 10  
TO  
AGREEMENT OF NOVEMBER 15, 2017  
FOR TOLL SYSTEMS  
OPERATIONS AND MAINTENANCE  
MASTER SERVICE AGREEMENT**

THIS SUPPLEMENTAL AGREEMENT is made and entered into this 21st day of November, 2022, and modifies the MASTER SERVICE AGREEMENT effective November 15, 2017 (the “Agreement”), by and between the Fort Bend Grand Parkway Toll Road Authority (the “Authority”), a Texas Local Government Corporation, and TransCore, LP (the “Contractor”), a limited partnership organized under the laws of the State of Delaware.

The Agreement is hereby modified as follows:

1. Section 3.04. Term and Termination:

This agreement is extended for three (3) months and all pricing for all services shall be firm for the three-month duration ending March 31, 2023. Either party may terminate this Agreement at any time, without cause, upon six (6) months written notice to the other party. Contractor shall not be entitled to any payment or further payment other than for work performed or material, equipment, or supplies furnished prior to such termination. The Authority does not waive any other remedy allowed under Texas law.

This Supplemental Agreement does not alter, modify, or otherwise change any part of the Agreement, except as specifically stated in this Supplemental Agreement.
