- 2. **Take all appropriate action to canvass the results of the Constitutional Amendments Election conducted on May 7, 2022, pursuant to Section 67.004 of the Texas Election Code.**

John Oldham, Elections Administrator indicated there were 34,376 out of 508,782 persons who participated in the election. The results were relatively overwhelming and both Amendments passed.

John Oldham, Elections Administrator indicated there were what is believed to be 7,175 persons, in the proposed district, with 963 who voted. Overall, the confirmation of the District passed; however, under the Health and Safety Code, parts of the District must be tabulated separately. The City of Needville passed within the ETJ, the Rosenberg ETJ failed by 3 votes and the Unincorporated area failed by 2 votes.

Judge George stated to let the record show the Election results of the Special Election held on May 7, 2022 were received for the Proposed Fort Bend County Emergency Services District No. 9.
