

Take all appropriate action on request to rescind agenda item 4 approved by the Drainage District on March 9, 2021, regarding the purchase of a vehicle, and take all appropriate action on the purchase of one (1) replacement vehicle for unit D714 from Grapevine Dodge Chrysler Jeep, utilizing Buyboard Contract No. 601-19, in an amount not to exceed \$55,116. (Fund: Certificates of Obligation)
4. Approve out-of-state travel for Juling Bao to San Diego, California, July 3, 2023 through July 14, 2023, to attend the Environmental Systems Research Institute User Conference. (Fund: Drainage District).
5. Take all appropriate action on the acceptance of a 10.963 acre drainage easement along Ditch H from NNP-Telfair LLC, Precinct 3.

Take all appropriate action on Agreement between Fort Bend Drainage District and Freese and Nichols, Inc. for professional engineering services regarding Kitty Hollow Lake Dam Repair Project in an amount not to exceed \$399,548 effective through March 10, 2025.
