**AMENDMENT TO AGREEMENT FOR

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and CivilTech Engineering, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on May 25, 2021, pursuant to RFQ 21-037 regarding the Big Creek Expansion Project, (hereinafter referred to as the "Agreement"); and

WHEREAS, the parties desire to further amend the Agreement to extend the contract term for the completion of services described in the Scope of Service for this Project, which is incorporated by reference.

NOW, THEREFORE, the parties do mutually agree as follows:

Time of Performance.

1. The time of performance of the Scope of Services under this Agreement shall be extended to end no later than August 31, 2025. Contractor shall complete the tasks described in the Scope of Services for this Project, within this time or within such additional time as may be extended by the County.


