
1. Call to Order.

  - A. Conduct public hearings on the proposal to increase the 2023 tax rate for Fort Bend County Drainage District.
  - B. Conduct Public Hearing on the Proposed FY2024 Budget of Fort Bend County Drainage District, pursuant to Texas Local Government Code Section 111.067.
4. Take all appropriate action to adopt the FY2024 Proposed Positions for Fort Bend County Drainage District.
5. Take all appropriate action to assign vehicles to the Drainage District as presented on FY2024 Fleet Management.
6. Take all appropriate action on list of take-home vehicles for the Drainage District for FY2024, pursuant to County Employee Information Manual, Policy 612.

7. Take all appropriate action to adopt the 2023 Tax Rate for Fort Bend County Drainage District, and take a record vote, pursuant to Property Tax Code 26.05, as follows:

Proposed Drainage District Maintenance Tax Rate:	\$0.0108;
Proposed Interest & Sinking Fund Tax Rate:	\$0.0016; and
Total Proposed Tax Rate:	\$0.0124.

8. Take all appropriate action to adopt the FY2024 Fort Bend County Drainage District Budget, and take record vote, pursuant to Texas Local Government Code Section 111.068.
9. Take all appropriate action on transfer in the amount of \$387,045 from Flood Contingency into 2023 Oyster Creek at FM 1092 Slope Repair Project No. 23001x to allocate funds to cover the cost of a contract modification with Shirley & Sons.
10. Take all appropriate action on transfer in the amount of \$505,716 from Flood Contingency into 2023 Oyster Creek at Lake Olympia Blvd. Slope Repair Project No. 23004x to allocate funds to cover the initial engineering contract.
11. Adjournment.
