



5. Take all appropriate action on request to purchase two (2) utility tractors from Deere & Company, utilizing Sourcewell Contract No. AG Tractors110719-JDC, in an amount not to exceed \$177,084.96. (Fund: Certificates of Obligation).
6. Authorize advertising for bids for Emergency Watershed Protection - Oyster Creek Channel Bank Stabilization Phase 4.
7. Adjournment.
