





(Fund: Drainage District)
4. Take all appropriate action on request to purchase one (1) boom mower and accessories from Tiger Mowers LLC, utilizing Sourcewell Contract No. 070821-TGR in an amount not to exceed \$67,607.36. (Fund: Certificates of Obligation)
5. Take all appropriate action on Phase II (Small) MS4 Annual Report for Texas Pollutant Discharge Elimination System General Permit No. TXR040000 for Fort Bend County Stormwater Quality Coalition, Year 5, for the reporting period of October 1, 2022, through September 30, 2023.
6. Take all appropriate action on reimbursement to the Fort Bend County Toll Road Authority in the amount of \$193,191.17 for detention and drainage facilities.
