

**AMENDMENT TO ADDENDUM TO SWAGIT PRODUCTIONS, LLC'S AGREEMENT  
CONCERNING THE EXTENSIBLE AUTOMATED STREAMING ENGINE SOLUTION  
(TIPS Contract No. 220105)**

THIS AMENDMENT ("Addendum") is entered into by and between Fort Bend County, ("County"), a body corporate and politic under the laws of the State of Texas, and Swagit Productions, LLC, ("Swagit"), a company authorized to conduct business in the State of Texas (hereinafter collectively referred to as the "parties").

WHEREAS, subject to the changes herein, the parties have executed and accepted the Addendum to Swagit's Agreement for Video Streaming Services and the Scope of Services, ("Agreement") on October 27, 2022, incorporated fully by reference, for the purchase of specified software products and services concerning the Extensible Automated Streaming Engine solution ("Services"); and

WHEREAS, the parties desire to amend the Agreement to reflect the change in Services to be provided and increase the total Maximum Compensation under the Agreement as described in Swagit's Quote attached hereto as Exhibit 1; and

WHEREAS, Swagit represents that it is qualified and desires to perform such Services; and

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Swagit an additional Fourteen Thousand Five hundred Thirty-Five Dollars and 00/100 (\$14,535.00) to perform the revised Services as described in Swagit's Quote attached hereto as Exhibit 1 and incorporated herein for all purposes.
2. The Maximum Compensation payable to Swagit for all Services rendered is hereby increased to an amount not to exceed Fourteen Thousand Five hundred Thirty-Five Dollars and 00/100 (\$14,535.00):

\$120,039.00	under the Agreement
\$ 14,535.00	under this Amendment

TOTAL:        \$134,574.00

3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without an agreement executed by the parties.
4. The term of the Agreement is effective as of January 1, 2023, and shall expire no later than September 30, 2023, unless terminated sooner pursuant to the Agreement. This

Agreement shall not automatically renew, but may be subsequently renewed in writing upon agreement of the parties in 1 year terms.

5. Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.


