**AMENDMENT TO AGREEMENT FOR
 CONSTRUCTION MATERIALS TESTING SERVICES**

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and HVJ Associates, Inc., (hereinafter "Consultant"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Construction Materials Testing on March 1, 2022 pursuant to SOQ 14-025, (hereinafter "Agreement"); and

WHEREAS, the parties desire to amend the Agreement to allow Consultant to provide additional Services and extend the Time of Performance under the Agreement.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Consultant an additional amount not to exceed nine thousand five hundred forty-two dollars and 50/100 (\$9,542.50) to perform the additional Services, as described in Consultant's proposal dated November 4, 2022 attached hereto as Exhibit "A" and incorporated herein for all purposes.
2. The Maximum Compensation payable to Consultant for all Services rendered is hereby increased to an amount not to exceed thirty-four thousand six hundred forty-one dollars and no/100 (\$34,641.00), authorized as follows:
 \$25,098.50 under the Agreement; and
 \$9,542.50 under this Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without an agreement executed by the parties.
4. The Time of Performance under the Agreement shall hereby be extended to end no later than December 31, 2026.
5. BY ACCEPTANCE OF AGREEMENT, CONSULTANT ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.



As requested, here we provide additional estimate/budget required for our scope of materials engineering and testing services to complete the above referenced project.

Scope of Services

Our scope of services for this additional estimate included following services

- Soil testing for backfill and subgrade
- Concrete testing for miscellaneous structure
- Applicable asphalt testing
- Associated laboratory testing of all materials

Cost Estimate

Our additional estimate to perform the material testing services to complete this project is estimated to \$9542.50 as shown on the attached breakdown. The estimate for our services is based on the review of information provided to us to complete the project and understanding the construction schedule of the contractor. However, we do not see our scope of testing involved more than above services we mentioned.

Our cost estimate is based on our best estimate, expected over run of previous budget considering the construction schedule and frequency of service requests from the client. This is an additional estimate for services based on the available information about the work required on the project. This time we do not anticipate revising budget anymore unless more work is added.

Our other terms and condition for the payment remains same per our last estimate. Invoicing to cover our additional services already presented and payment for these invoices are requested on approval of the additional estimate.


