
Dear Ms. Lindemann,

This letter is to advise of the impact to business card prices with the addition of a QR Code. There will be no change in pricing for single-sided or double-sided business cards with the addition of a QR Code, with two caveats:

1. The QR Code must be provided by FBC. The QR Code can be provided in a vector-art file (.eps) or a .png. The file provided **MUST BE** in black, i.e. no color at all. If the file is provided in color, we will convert it to black and there will be an additional \$25.00 typesetting charge on the invoice. As long as the artwork is provided in black, there will be no additional charge.
2. If the business card order is normally a single-sided business card and the order requests the QR Code be placed on the back of the card, that order will be charged the standard double-sided business card pricing per the contract. For example, because of the size limitations on the front of the card, the person ordering wants the Code to be placed on the back (and that is the only item on the back), the charge will be for a double-sided card.
