ADDENDUM TO THIRD AMENDMENT TO ZOLL MASTER AGREEMENT BETWEEN FORT BEND COUNTY AND ZOLL DATA SYSTEMS, INC.

THIS ADDENDUM TO THIRD AMENDMENT ("Addendum") is entered into by and between Fort Bend County, ("County"), a body corporate and politic under the laws of the State of Texas, and ZOLL Data Systems, Inc., ("ZOLL"), a company authorized to conduct business in the State of Texas (collectively referred to as the "parties").

WITNESSETH:

WHEREAS, the parties previously entered into the ZOLL Master Agreement, on or about October 8, 2019; and as amended on or about March 2, 2021, March 22, 2022, and November 22, 2022 (such amendments being the "First Amendment," "Second Amendment," and "Third Amendment" together with the ZOLL Master Agreement collectively referred to as the "Agreement"). The Agreement is incorporated fully by reference as if set-forth verbatim below; and

NOW, THEREFORE, County and ZOLL desire to amend said Agreement as set forth below:

I. Amendments

- 1. **Scope of Services**. ZOLL shall continue to provide product and/or services as described in the Agreement.
- 2. Limit of Appropriation. As provided by Section 7.2 of the ZOLL Master Agreement, ZOLL's fees are subject to adjustment based on quantity, and the parties seek to revise the amount of compensation paid to ZOLL due to increase use of ZOLL's product and/or services by County. ZOLL's monthly fees and audit adjustment will be calculated at the rates set forth in ZOLL's Invoices (Invoices # INV00127276 and # INV00127275), collectively attached as Exhibit "I" and incorporated fully by reference. The Maximum Compensation for the performance of Services is hereby increased to an amount not to exceed One Hundred Seventy-Eight Thousand, Five Hundred Sixty-Eight Dollars and 13/100 (\$178,568.13), authorized as follows:

\$141,512.88 under the Agreement; and

\$37,055.25 under this Addendum

In no case shall the amount paid by County for all Services under the Agreement and this Addendum exceed this Maximum Compensation without an agreement executed by the parties.

- 3. **Modifications**. Except as modified herein, the Agreement remains in full force and effect and has not been modified or amended.
- 4. **Conflict**. If there is a conflict among documents, the most recently executed document will prevail with regard to the conflict.

- 5. **Understanding, Fair Construction.** By execution of this Addendum, the parties acknowledge that they have read and understood each provision, term and obligation contained in this Addendum. This Addendum, although drawn by one party, shall be construed fairly and reasonably and not more strictly against the drafting party than the nondrafting party.
- 6. **Severability.** If any provision of this Agreement is determined to be invalid, illegal, or unenforceable, the remaining provisions remain in full force, if the essential terms and conditions of this Agreement for each party remain valid, binding, and enforceable.
