**FIFTH AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL ENGINEERING SERVICES**

THIS FIFTH AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter “County”), a body corporate and politic under the laws of the State of Texas, and Bowman Consulting Group, Ltd. formerly known as Terra Associates, Inc., (hereinafter “Contractor”), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on May 22, 2018, (hereinafter “Agreement”) pursuant to SOQ 14-025, as amended by documents dated February 2, 2019 (hereinafter the “Amendment”), July 9, 2019 (hereinafter the “Second Amendment”), June 2, 2020 (hereinafter “Third Amendment”), and February 22, 2022 (hereinafter “Fourth Amendment”); and

WHEREAS, the County consents to the assignment by Terra Associates, Inc. (hereinafter “Terra”) to Contractor all of Terra’s rights, title and interest in, to and under the Agreement; and

WHEREAS, the parties desire to further amend the Agreement to extend the Time of Performance.

NOW, THEREFORE, the parties do mutually agree as follows to extend the Time of Performance under the Agreement to end no later than December 31, 2024.

BY ACCEPTANCE OF AGREEMENT, CONTRACTOR ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement and any subsequent amendment shall remain unchanged.

IN WITNESS WHEREOF, this Fifth Amendment is signed, accepted, and agreed to by all parties by and through the parties or their agents or authorized representatives. All parties acknowledge that they have executed this legal document voluntarily and of their own free will.
